## Funding cutting-edge RESEARCH

The MPS Society has been funding cutting-edge research into MPS, Fabry and related diseases since its inception in 1982.

To this day, we have spent over £12 million on research projects into these conditions, to find better treatments and care. Scientific breakthroughs and new technologies offer hope for diagnoses and treatments for those affected that was unimaginable a few years ago.

The sooner we can accelerate our research and take advantage of these opportunities, the quicker we can help even more people affected by MPS, Fabry or a related disease. We can only do this with support from our community leaving a gift in their will and we are truly grateful for any gift big or small.

### Working towards EARLIER DIAGNOSIS

We know the sooner a family can receive a diagnosis the sooner the child or young adult can receive life-changing treatment.

As part of the MPS Society research strategy, we have awarded a grant to employ a scientist at Great Ormond Street Hospital to evaluate a new piece of equipment that could significantly improve our ability to identify patients with lysosomal storage

disorders. At the end of the study, a recommendation will be made as to whether this technique is suitable to support earlier diagnosis.

Research like this is only possible thanks to our community leaving a gift in their will. Together we can accelerate our research and help even more people affected by MPS, Fabry or a related disease.

### THINGS TO CONSIDER when making your will

### Planning your will

When you begin thinking about your will it can be a good idea to write down all your assets and then decide what you would like to leave and to whom.

#### Inheritance Tax

InheritanceTax is a concern for many people when planning a will. Including a gift to charity, of any amount, could be a good way to reduce the amount of inheritance tax your estate may be subject to.

Any gift you leave to the MPS Society will be exempt from Inheritance Tax.

#### Funeral plans

You may want to consider including any funeral wishes or plans in your will. Many people choose to plan for their funerals in this way so that it is one less thing for your loved ones to worry about.

#### Reviewing your will

It is recommended that you review your will regularly, especially at important life stages.

This might be an item of value that can be sold or that may benefit the charity in other ways, such as property or jewellery.


